

# EGate Privacy Policy

## INTRODUCTION

- EGate is committed to safeguarding the privacy of the users of the Site.
- EGate has reasonable security measures in place to protect against the loss, misuse and interception by third parties of the information under its control, but, to the extent permitted by law, and we assume no liability for any loss or damages that the User or anyone else may suffer as a result of interception, alteration or misuse of information transmitted over the Internet.

## INFORMATION COLLECTED

- EGate may choose to collect personal information from you via our Site through the use of enquiry and registration forms and every time you e-mail us your details. EGate may track the Internet address of the domains from which people visit us and analyze this data for trends and statistics, but the individual user remains anonymous.

## USE AND DISCLOSURE OF PERSONAL INFORMATION

  - The only information that EGate might disclose to third parties is aggregate information about our users.

- In order to provide the best possible and most relevant service, we may use standard technology to collect information about the use of this site. This technology is not able to identify individual users but simply allows this web site to collect statistics.
- EGate will only disclose your personal information to third parties in the following instances:
  - you have consented thereto;
  - Where EGate uses a third party to assist in providing services and the User have elected to receive one of those services. The third party would only be permitted to use your information for the purposes of providing that service to you;or
  - EGate is compelled by law or a Court order to do so; OR
  - If EGate believes that such action is necessary for the purposes of the legitimate interest pursued by EGate, in order to protect and defend the rights, property or safety of EGate, the Site, visitors to the Site or others.

- EGate may, in our sole discretion, contact any/all law enforcement authorities if EGate believes that anything unlawful is occurring in connection with the Site. In such instance, EGate may provide the law enforcement authorities with any/all personal information held.
